NAME Sales Room Dealer Application Instructions

Deadline: November 1, 2024

NAME invites you to apply to be a Dealer at their National Convention or Regional Houseparty. To be considered, you do not need to be a NAME member, but NAME members will receive first priority. If you are interested, please complete the following application, and send it, along with the requested enclosures, to the NAME Office at the address below.

Please note the following important information:

- 1. Application deadlines are posted in the Miniature Gazette and on the NAME website: www.miniatures.org. Accurate and timely applications (that conform to the rules) are vital to the decision-making process.
- 2. A separate application must be sent for each Convention/Houseparty. You may indicate the event for which you are applying on **either** line 1 **or** 2 on the application form not both.
- 3. Photographs or computer-generated pictures: remember, this is the time to really represent your product at its best, so make it count! Be sure your pictures are sharp and show your work clearly. All photos should be on a single page. Some members of the selection committee may not be familiar with your work. Product close-ups illustrating your range of items and table display are good choices.
- 4. The NAME logo is trademarked and, as such, may not be used in any products without prior written approval by the NAME Board of directors. Use of other corporate logos is subject to their restrictions.
- 5. A committee including 5 voting members for a Convention (3 voting members for a Houseparty) will discuss and consider each application carefully. Selection criteria include quality of merchandise, variety, scale and to some degree other involvement in the Convention/Houseparty. The committee strives to build a well-balanced sales room that will be appealing to our registrants and successful for our dealer.
- 6. If you are selected as a Dealer at the Convention/Houseparty, you will be sent VIP Registration forms with your acceptance letter. Unless you are a Business Member, you are required to register to attend the Convention or Houseparty to be a dealer in our sales room.
- 7. Upon acceptance, you will receive an Agreement. By returning the completed agreement along with the table fee you agree to abide by the NAME Code of Ethics. Return or email the contract to the NAME Office by the deadline indicated in your acceptance letter to avoid cancellation of your acceptance as a dealer. *Extra tables require an additional fee equivalent to the price for a single table. Additional tables are not discounted.

Please **email** the application, and pictures to <u>kim@miniatures.org</u>. There is no fee to apply <u>electronically</u>. Your application and picture page will be uploaded to a secure cloud location for the selection committee to review.

If you choose to <u>mail</u> your application and pictures, please include a \$5 processing fee. You may either send a check or money order to the address below or pay via PayPal to: <u>name@miniatures.org</u> Be sure to include description of payment with check or PayPal. Your application and picture page will be scanned and uploaded to the cloud for the selection committee to review.
